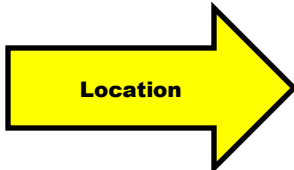


STOCK DOG FALL SHEEP TRIAL – November 4th, 2017
